Development and Manufacturing of Carbon Materials

Need equity investment to build a manufacturing line.

Since our materials are made from methane, we are aware of the possibility of contributing to the challenges in the Middle East region and would like to explore collaboration.

We are a spin-off start-up of Tohoku University, a top-ranked university in Japan. We own a carbon material called "Graphene Mesosponge(GMS)" that was invented at Tohoku University, and that can greatly improve battery performance using methane as a raw material.

GMS is the 1st carbon material that can buffer electrodes' expansion and contraction, a common problem for higher-energy batteries.

Since it has a precisely-controlled 3D structure of a single atomic layer, it can absorb electrodes' expansion and contraction by deforming elastically.

3DC's cutting-edge carbon material, "GMS (Graphene MesoSponge)," is the first mass-producible carbon material with actual single-layered graphene. That exceeds the limits of battery performance and cycle life.

3DC's Graphene Meso-sponge (GMS) is the critical material for next-gen higher energy batteries.
